### **Eligibility**

The minimum age limit for the retreat is 21; there is no maximum age limit. However, we recommend that participants be in excellent health and able to participate in trip activities, which may include walking over uneven or rocky terrain to moderately inclined terrain for a period of two hours. Wild Hair Adventures reserves the right to decline to accept any person as a member of this tour at any time.

### **Covid Immunization**

All participants show official documents with the date of covid immunization noted. Immunization must be shown as being fully completed at least one month before arriving in Greece.

### **Illegal Property or Drugs**

Participants may not have in their possession any type of arms, ammunition, or illegal drugs during any part of the retreat.

### **Itinerary or Program Modifications**

While every effort will be made to carry out the program as planned, the program is subject to modification and change to take advantage of new opportunities.

### **Photography and Written Records**

### **Cancellation and Refunds**

Written cancellation is required to process a refund. For reservations cancelled by August 15, 80% of the amount paid is refundable. If cancelled between August 16 - November 1, 50% of the amount paid is refundable. Between November 2 and January 24, 20% is refundable. After January 25, fee is non-refundable.

Although unlikely, the tour may be canceled due to unforeseen circumstances. Instructors have no obligation regarding any additional costs or fees related to the issuance and/or cancellation of airline tickets or other travel reservations.

Group Leaders accept no liability for any airline cancellation penalty incurred by the purchase of a non-refundable ticket or for canceled flights. Travel Insurance is strongly recommended (see below).

### **Cancellation Due to Covid**

If closure of the US or Greece is in place or imminent in April of 2022, or earlier if it seems prudent, this trip will be cancelled and available funds returned.
